Dear Chief Justice Cantil-Sakauye and Associate Justices of the Court:

Andor Molnar, former President of the Los Angeles County Board of Realtors, strongly urges this Court to accept review of the decision in this case. As the former President of the Los Angeles County Board of Real Estate, I am extremely concerned about the repercussions to property owners as a result of the court's decision, and the impact on California's housing market.

As a result of the court's ill-informed decision, millions of California homeowners will be affected. The value of their homes will drop, and their ability to sell will virtually vanish. Los Angeles will be particularly hard hit. More than one-third of the homes in Los Angeles were built before 1951, which is more than 900,000 residential units, including many housing units occupied by low- and moderate-income families. All will be subject to inspection and abatement of lead-based paint hazards. In other words, an enormous number of Los Angeles residents are about to be told their homes are in violation of the law and will remain so until even intact lead paint is removed from certain friction surfaces.

The public nuisance designation will inevitably cause property values to fall. And regardless of what the court said about the court-ordered abatement plan being voluntary, abatement of a nuisance under California law is mandatory.

Owners looking to sell their homes will fare no better. What notice does an owner have to give tenants of pre-1951 residences? What is the effect of being on the “naughty list” of owners who refuse to participate in the court-ordered abatement plan? No bank will approve a mortgage until the nuisance situation is rectified, a process that in many cases will take months or even years to complete. For large numbers of the aging who depend on their home as their nest egg, this will be a devastating blow. Lower property values mean less tax revenue for these cities and counties, which means less money for schools, police, pensions, and other community needs.

For the aforementioned reasons, this Court should grant the Petition for Review.
